MEMORANDUM OF AGREEMENT

SUBMITTED TO THE OKLAHOMA STATE HISTORIC PRESERVATION OFFICER AND TO THE ADVISORY COUNCIL ON HISTORIC PRESERVATION PURSUANT TO 36 CFR 800.6(a)

WHEREAS, the U.S. Army Corps of Engineers, Tulsa District (COE), has determined that the Creek Turnpike, Polecat Creek Crossing, will have an effect upon the Perryman Station (also known as the Creek Station and Bow Pipeline Building), a property eligible for inclusion in the National Register of Historic Places, and has consulted with the Oklahoma State Historic Preservation Officer (SHPO) pursuant to 36 CFR Part 800, regulations implementing Section 106 of the National Historic Preservation Act (16 U.S.C. 470f); and

WHEREAS, the Oklahoma Turnpike Authority (OTA) participated in the consultation and has been invited to concur in this Memorandum of Agreement (MOA);

NOW, THEREFORE, the COE and the Oklahoma SHPO agree that the undertaking shall be implemented in accordance with the following stipulations in order to take into account the effect of the undertaking on historic properties.

Stipulations

The COE will ensure that the following measures are carried out:

The OTA shall protect the Perryman Station, located near 106th and Elwood Avenue South, Jenks, Tulsa County, Oklahoma, scheduled for treatment in accordance with the stipulations cited below, against damage while in the ownership of the OTA, until such time as the applicable treatment measures are implemented;

The OTA shall have prepared a report on the Perryman Station consisting, at a minimum, of the following elements: an historic context for the site; architectural drawings showing the site plan, elevations, floor plans, and interior details; and interior and exterior architectural photographs;

The OTA shall have all work done pursuant to this MOA conducted by or under the supervision of persons meeting the professional qualifications for historian and/or architectural historian as stated in the Secretary of the Interior's Qualifications Standards (48 FR 44738-9);

The COE shall ensure that the Oklahoma SHPO is afforded the opportunity to review and comment on the scope of work for documentation of the Perryman Station;

The COE shall file the documentation and report with the Oklahoma SHPO.

Execution of this Memorandum of Agreement by the COE and the Oklahoma SHPO, its subsequent acceptance by the Advisory Council on Historic Preservation

(Council), and implementation of its terms, evidence that the COE has afforded the Council an opportunity to comment on the Creek Turnpike, Polecat Creek Crossing, and its effect on historic properties, and that the COE has taken into account the effects of the undertaking on historic properties.
