

MEMORANDUM OF AGREEMENT

WHEREAS, in accordance with the provisions of the Housing and Community Development Act of 1974, the City of Guthrie, Oklahoma, proposes to implement the Guthrie Floodway Acquisition/Relocation Project. This project will be funded by the Department of Commerce through a Community Development Block Grant. The purpose of the project is to purchase residential property, relocate the residents, demolish and clear the purchased properties.

WHEREAS, the City of Guthrie, Oklahoma, in consultation with the Oklahoma State Historic Preservation Officer, has determined that implementation of this project will adversely affect properties included in or eligible for inclusion in the National Register of Historic Places, and;

WHEREAS, pursuant to Section 106 of the National Historic Preservation Act of 1966 (16 U.S.C. 470f, as amended, 90 Stat. 1320), the City of Guthrie, Oklahoma has requested the comments of the Advisory Council on Historic Preservation, and;

WHEREAS, pursuant to the procedures outlined in the Section 106 update to the procedures of the Advisory Council on Historic Preservation (36 C.F.R., Part 800), the Agency Official and the Oklahoma State Historic Preservation Officer have consulted and reviewed the proposed undertaking to consider alternatives to avoid or satisfactorily mitigate effects on historic properties, now;

THEREFORE:

It is mutually agreed that implementation of the Community Development project cited above in the City of Guthrie, Oklahoma, in accordance with the following stipulations, will provide measures adequate to avoid or satisfactorily mitigate any adverse effects and will therefore constitute satisfactory compliance with Council procedures.

Stipulations

- Stipulation #1: All properties to be affected by the project will be documented by the City of Guthrie by completion of an Historic Preservation Survey Inventory Form accompanied by at least one clear photograph.
- Stipulation #2: In addition to the above documentation, for the properties known as 1004 West Grant, 1009 West Grant, 514 West Oklahoma, 323 North 7th, 823 West Mansur, and 716 West Washington, the City of Guthrie will prepare a brief narrative history on each property. These properties are considered to be of special interest and/or unique types not duplicated in other areas of Guthrie. The narrative will include, but not be limited to, the building's history, the construction technology of the building and the use of the building. Sufficient photos of each building to illustrate general views, details, and the setting of the building will accompany the narrative.

The City of Guthrie, Oklahoma agrees to encourage the use of Community Development funds for the preservation, rehabilitation and restoration of districts, sites, buildings, structures, and objects included in or eligible for inclusion in the National Register of Historic Places.
