

## MEMORANDUM OF AGREEMENT

SUBMITTED TO THE ADVISORY COUNCIL ON HISTORIC PRESERVATION  
PURSUANT TO 36 CFR § 800.6(a)

WHEREAS, the City of Oklahoma City has determined that rehabilitation of the First United Methodist Church, 131 Northwest 4th Street, Oklahoma City, will have an effect upon the building, an individual resource which for its architectural significance and for its association with the historical development of north downtown Oklahoma City, is eligible for inclusion in the National Register of Historic Places, and has consulted with the Oklahoma State Historic Preservation Officer (SHPO), Pursuant to 36 CFR Part 800, regulations implementing Section 106 of the National Historic Preservation Act (16 U.S.C. 470f); and

NOW THEREFORE, the City of Oklahoma City and the Oklahoma SHPO, and the Council agree that the undertaking shall be implemented in accordance with the following stipulation in order to take into account the effect of the undertaking on historic properties.

### STIPULATIONS

First United Methodist Church  
131 Northwest 4th Street, Oklahoma City, Oklahoma

The City of Oklahoma City will ensure that the following recordation measures are carried out in consultation with the Oklahoma SHPO prior to its alteration of the First United Methodist Church.

#### Measures:

Performance Standards of the Historic American Building Survey/Historic American Engineering Record (HABS/HAER).  
Prior to the alteration of the First United Methodist Church, 131 Northwest 4th Street, the City of Oklahoma City shall contact HABS/HAER Coordinator, National Park Service (NPS), Southwest System Support Office 12795 W. Alameda Parkway, Denver, Colorado 80225, to determine what level and kind of recordation is required for the property. Unless otherwise agreed to by NPS, the City of Oklahoma City shall ensure that all documentation is completed and

accepted by HABS/HAER prior to the alteration, and that copies of this documentation are made available to the SHPO and appropriate local archives designated by the SHPO.

Execution of this Memorandum of Agreement by the City of Oklahoma City and the Oklahoma SHPO, its subsequent acceptance by the Council, and implementation of its terms evidence that the City of Oklahoma has afforded the Council an opportunity to comment on the rehabilitation of the First United Methodist Church, 131 Northwest 4th Street, and its effects on historic properties, and that the City of Oklahoma City has taken into account the effects of the undertaking on historic properties.
